The tender (Cover-I) shall be accompanied with earnest money for an amount of **Rs.300000.00 (Rupees Three lac only)**, in the shape of (**CDR / TDR/ FDR/ BankGuarantee**), issued by a scheduled bank having a branch in Srinagar city which shall be pledged to the **Superintending Engineer, Mechanical Circle, Mechanical Engineering Department, Shalteng Srinagar, Kashmir**. No concession shall be entertained in respect of earnest money irrespective of the fact whether the Firm (intending Bidder) is registered with DGS&D/ Small Scale Industries Corporation etc. for the equipment /job quoted for.
