General Terms & Conditions: -

1. Prices:

The unit rates and prices shall be quoted by the bidder entirely in Indian Rupees and the rates quoted shall be covered with transparent tape & also deemed to include price escalation and all taxes as applicable up to completion of the supply of items.

2. The cost of tender documents is non-refundable and the tender shall in no case be accepted if submitted by any firm other than the purchaser.
3. Any tender found to have been submitted by the firm by furnishing false information to the department shall be cancelled and the firm shall be penalized as and when it comes to the notice of the Department even during the currency of the contract.
4. The tender should be addressed to **Executive Engineer Mechanical Division Srinagar.**
5. **Completion Period:** The works has to be completed within 10 days from the date of issue of letter of intent or placement of order whichever is earlier.
6. **Terms of Payment:** On completion of all the contractual obligations and **subject to the availability of funds**, the Contractor shall be paid as per details given hereunder:
 - a. 80% of the total cost of order shall be released after tyres are received in full FOR Divisional Stores Pampore and after verification by the concerned AEE thereof.
 - b. Balance 20% shall be released after successful performance of material for one year or 20,000 kilometers whichever is earlier. However, the balance payment can be released against production of an irrevocable bank guarantee from a scheduled or nationalized bank having a branch in Srinagar equivalent to the balance 20% of the payment.
7. **Security Deposit:** The CDR/FDR shall remain as security deposit with the department which shall be released after the warranty period of the material is over.
8. **Materials & Workmanship:**
 - (a) All the material & workmanship shall be of highest class and quality capable of satisfactory operations when exposed to extreme/ specified atmospheric conditions.
 - (b) All the material shall comply with the requirement of tests specified in the Governing standards and additional other tests as specified in the contract.
9. **Performance /Guarantee/warranty:** The firm shall guarantee that all the material supplied by him shall be free from defects due to faulty material and/or workmanship that the system shall

perform satisfactory and all the material shall not be less than the parameters laid down in the specifications. In case of any shortcomings the firm shall replace it at no extra cost.

10. **Penalty:**The work has to be completed within stipulated time period failing which the department shall with or without prejudice to any other alternative available, forfeit the earnest money deposit and impose penalty upto 10% of the total value of contract besides recovering cost, if any involved in getting work completed through any other agency. Besides the firm shall be blacklisted.
11. **Cancellation:-** The Department reserves the right to cancel the order in case of default on the part of the contracting agency and also prior to the receipt of the intimation regarding taking in hand the execution of contract against the supply order. No claim whatsoever shall be tenable against the purchaser on this account.
12. **Agreement:** Successful tenderer shall draw an agreement with the department within tendays from the date of issue of formal allotment order.
13. **Court's Jurisdiction:-**In case of any disputes/differences between firm and the Department the jurisdiction shall be within J&K Courts at Srinagar.
14. **Arbitration:** If at any time, any dispute or difference whatsoever shall arise between the firm and the government in relation to or in connection with the contract the same shall be referred to the arbitration of a person to be appointed by the Government of Jammu & Kashmir whose decision shall be final and binding upon both the arbitration. The arbitration shall be within jurisdiction of the J&K State only.
15. **Correctness and Completion of Stores:** - The store will be completed in every respect with fittings, Fixtures etc. which are normally supplied even though not specially mentioned in the specifications. The firm shall not be eligible for payment in respect of such fittings, fixtures etc. which are needed for safe operations. The firm shall be responsible for completeness of the items and for efficient working performance of the same at site.
16. The payment making authority shall be **Executive Engineer, Mechanical Division, Srinagar.**
17. **All other terms and conditions** shall remain same as laid down in PWD form No. 25.
